

McDonald's Maestro Promotion Terms & Conditions

1. The McDonald's Maestro Promotion (the "**Offer**") is provided by Premier Restaurants Malta Limited with registration no. C 18843 of Nineteen Twenty Three, Valletta Road, Marsa, MRS 3000, Malta ("**McDonald's**"), subject to the following terms and conditions (the "**Conditions**").
2. Unless otherwise determined by McDonald's, the Offer shall run from the 5th May 2017 until the 14th June 2017 (the "**Offer Period**").
3. The Offer shall be valid exclusively from McDonald's restaurant, Malta International Airport (the "**Store**").
4. Throughout these Conditions, any reference to "**Maestro McMenu Meal**" shall mean any sandwich from the Maestro Range + large fries + large drink.
5. Each person who purchases a Maestro McMenu Meal may avail themselves of either one (1) free apple pie, **or** one (1) free regular drink.

Eligibility

6. Any person, being of 18 years of age or over, who buys a Maestro McMenu Meal is eligible to participate in the Offer (the "**Participant**").
7. A coupon (the "**Coupon**") shall be distributed upon purchase of any McDonald's product, however, **ONLY** customers purchasing a Maestro McMenu Meal shall be eligible to participate in the Offer.
8. By utilising the Coupon, Participants unconditionally agree to be subject to the Conditions set forth herein.
9. No other McDonald's meals and/or products, whether purchased separately or in conjunction with any other products/offers, are eligible for this Offer and, consequently, shall not entitle the customer to a free apple pie or free regular drink, nor shall it entitle the customer to participate in the Offer.
10. Coupons are distributed to customers who purchase any McDonald's product from the Store as dine-in, take-away or from the drive-thru.
11. Subject to any limitations set out herein, there is no restriction on the number of times a customer may participate in the Offer. Provided that only one (1) entry per Coupon shall be allowed.
12. McDonald's employees, any direct suppliers and/or affiliates (including partners and members of their immediate family) are not eligible to participate in the Offer.

Procedure of Offer

13. Upon being provided with the Coupon, customers whose purchase consisted of a Maestro McMenu Meal must fill in the Coupon with their details, as well as fill in the answer to a question found on the Coupon itself. It is at the discretion of McDonald's what questions are to be put on the Coupon.
14. Once the details on the Coupon are filled in and the question answered, the customer must attach to the Coupon the receipt proving purchase of a Maestro McMenu Meal. Stickers enabling the customer to attach the receipt to the Coupon will be made available at the Store.
15. The customer must then proceed to place the Coupon with the attached receipt in a ballot box which will be placed in the lobby of the Store.
16. There shall be three (3) winning participants (the "**Prize Winners**").
17. The Prize Winners will be selected on the 30th June 2017 by way of a random draw which shall be conducted in the presence of a legal officer.
18. The selected Coupons must bear a correct answer to the question found on the Coupon in order to be considered Prize Winners.
19. The Prize Winners will be contacted through the personal details found on the winning Coupons within one (1) week from when the random draw is conducted. The Prizes are forfeited if the Prize Winners cannot be contacted, or if the Prize Winners fail to claim the Prizes within one (1) week from notification. The Prize Winners shall be notified as to when and where the respective Prizes (as defined hereunder) can be collected. Upon such forfeiture, replacement winners will be picked by way of a random draw.

Description of Prizes

20. The Participant whose details are found on the Coupon which is drawn first will win the first prize (the "**First Prize**"), consisting of a seven (7) night trip to Crete for two (2) persons, including flights and a 3-star accommodation on a half-board basis;
21. The First Prize shall be subject to the following conditions:
 - (a) The dates for the First Prize trip are fixed from the 1st to the 8th of September 2017 (the "**Trip Dates**")
 - (b) The First Prize will not be valid if not used during the Trip Dates
 - (c) In the event that the winner of the First Prize is unable to make the trip during the Trip Dates, McDonald's is not bound to substitute

22. The Participant whose details are found on the Coupon which is drawn second will win the second prize (the “**Second Prize**”), consisting of a two (2) night weekend break in a 5-star hotel in Malta for two (2) persons on a bed and breakfast basis;
23. The Second Prize shall be subject to the following conditions:
 - (a) The Second Prize shall be valid for the weekend periods between the months of July 2017 and December 2017
 - (b) The winner of the Second Prize shall book the Second Prize at least four (4) weeks prior to the intended weekend of stay through McDonald’s
 - (c) Dates of the stay shall be subject to availability on the requested dates
 - (d) In the event that the winner of the Second Prize is unable to stay at the 5-star hotel on any of the valid weekend periods, or booked dates, McDonald’s is not bound to substitute
24. The participant whose details are found on the Coupon which is drawn third will win the third prize (the “**Third Prize**”), consisting of a brand-new set of Beats headphones.
25. The First Prize, Second Prize and Third Prize (collectively the “**Prizes**”), are non-transferrable and may not be given, assigned or sold to another person. The Prizes cannot be exchanged for cash or other alternatives or used in conjunction with any other offer or discount. McDonald’s reserves the right to substitute any Prizes with another of equivalent value without giving notice.
26. McDonald’s is not responsible for inaccurate details in relation to the Prizes supplied by any third party connected with this Offer. McDonald’s is not responsible for the cancellation or modification of the Prizes supplied by third parties.

Other General Conditions

27. The Offer shall run in accordance with these Conditions, subject to any amendment which may be made at McDonald’s sole discretion and at any time during the Offer Period.
28. McDonald’s reserves the right at any time to modify these Conditions and/or modify, suspend or discontinue, temporarily or permanently, the Offer (or any part thereof) with or without prior notice and without incurring any liability thereof.
29. Saving the provision within Clause 27 and Clause 28, these Conditions are not subject to amendment or counter-offer.
30. McDonald’s is not responsible for any misdirected, late or incomprehensible entries in relation to the Offer.
31. Handing over the Prizes to the Prize Winners shall release McDonald’s from any obligation to the fullest extent permitted by law. McDonald’s shall not be held liable in any way, for any claims arising

out of and/or relating to the use of the Offer and/or the Prizes, including but not limited to, claims for personal injury and/or damage caused to the Prize Winners, their guests, and/or any other third party.

32. McDonald's does not accept any liability if the Prizes are lost, delayed or damaged in the post or otherwise not validly received by the Prize Winners.
33. McDonald's decision in respect of all matters to do with the Offer will be final and no correspondence will be entered into.
34. By participating in this Offer, the Participants agree to be subject to these Conditions.
35. The Prize Winners agree to the use of their name and images in any publicity material without any compensation. Any personal data relating to the Prize Winners or any other Participants will be used solely in accordance with current Maltese data protection legislation and will not be disclosed to a third party without the Participant's prior consent.
36. These Conditions constitute the entire agreement between McDonald's and the Participants of the Offer, pertaining to the subject matter herein and supersede all prior or other arrangements, understandings, negotiations and discussions, whether oral or written. No waiver of any of the provisions of these Conditions shall constitute a waiver of any other provisions hereof (whether or not similar), nor shall such waiver constitute a continuing waiver unless otherwise expressly provided.

If any part, clause or provision of these Conditions shall be held by any court or other tribunal, including any arbitral tribunal, of competent jurisdiction to be illegal, void, invalid or unenforceable for any reason, the remaining clauses, or the remaining part(s) of a clause, as may be applicable, shall not be affected and shall continue to be valid and enforceable.

The Offer and these Conditions will be governed by Maltese law and any disputes, controversies and/or claims arising out of or in connection with the Offer and/or these Conditions shall be governed and construed in accordance with the Laws of Malta and subject to the exclusive jurisdiction of the Courts of Malta.
